Will be hosted by Laura Lambert Friday, September 17, 2021 at the Goshen County Fairgrounds in Torrington Wyoming in conjunction with the Jody Motley Memorial Barrel Race produced by Laura Lambert. We will drag after 5 runners and you may roll your time back to the Jody Motley Open Race that day.

Top 12 in the 2021 Mtn. States DC standings as of August 18, 2021 are invited. Others below the 12th position in the standings are invited to enter but not guaranteed to run. Qualification cut off is August 18th, 2021. Top 12 in the 2021 Mtn States DC standings can be found at www.wpra.com.

If the top 12 don't all enter finals, we will drop down to the next person in the 2021 Mtn States DC standings **who entered the Mtn States DC Finals.**

Entries open by EMAIL on Monday August 30th at 8 am Mtn time and close on Monday August 30th at 8 pm, Mtn time.

All entries must be emailed to Carla.Beckett@wpra.com with the contestants name, card number, and phone number. You will receive an email confirmation of your entry. If you do not receive an email you are not entered. No entries will be taken by phone.

Finals will be 1 run, with entry fees of \$55 and a \$20 office charge. Fees are required to be paid prior by mail and received by September 10th, 2021. Mail entry checks payable to Carla Beckett, 23 Mill Iron Road, Laramie, WY 82072. If entry fee is not received by the deadline we will drop down to the next eligible person who entered.

Once entry fees are paid there are no releases or refunds. You must check by **6 pm** the day of the race. If you do not check in your spot will be given to the next eligible person who entered and is present at the race.

Entries open by EMAIL on Monday August 30th at 8 am Mtn time and close on Monday August 30th at 8 pm, Mtn time.

All entries must be emailed to Carla.Beckett@wpra.com with the contestants name, card number, and phone number. You will receive an email confirmation of your entry. If you do not receive an email you are not entered. No entries will be taken by phone.

Finals will be 1 run, with entry fees of \$50 and a \$20 office charge. Fees are required to be paid prior by mail and received by September 10th, 2021.
