

2013 Rules, Clarifications & Waiver This form must be signed and accompany entry form



- **NO DOGS** allowed in the indoor arena. Dogs must be on leash at all times.
- Horse must be named on entry form. Please enter with horse's registered name.
- Horse and rider must run in order drawn or be disqualified. There is no charge for a horse change in the 5D to substitute a horse that is not already in the existing pre-entry or late draw. Please see the office before 8:30 am.
- **Open 5D** will be ½ second splits and will run at 9:00am. 5D Average Buckles will be based on the fastest time from each day. You need not be present for awards but must pay shipping to receive award. 70% of entry fee, 100% of added money will be jackpotted.
- \$1500 Cash Target Race side-pot c/o from 5D horse and rider with the two closest times Sat & Sun will win \$1000 cash. 2nd place \$300, 3rd place \$200!
- **5D Dress code** Western casual ⁽²⁾ long pants, western boots.
- **5D Entries** must be postmarked by 9/18/13 to avoid a \$10 late fee. Late entries will be taken day of race until the last 50 runners and will be charged a \$10 late fee. Late entries taken on Saturday for both days will run after pre-entries on Saturday and Sunday. Late entry draw will be done & posted before the last 75 runners in the pre-entry draw. Pre-entered day runners will be included in the draw. There will be separate draws done for the Open 5D Saturday and Sunday, late entries will run after pre-entries Saturday and Sunday. The pre-entry draw will remain unchanged. We will not fill vet-outs or scratched spots with late entries. We reserve the right to fill vet-outs and scratched spots in the event we have made an error or deem necessary. Late entries with multiple horses will be split to the best of our ability. The later you enter the less likely it will be that we can split up multiple horses.
- All runners will enter the arena thru the alley way and exit out the alley way. No exceptions. One circle is allowed. Any runner entering from anywhere other than the alley way will be disqualified. If you are in the warm-up arena, please be cautious and courteous of horses running in and out of the alley way. The next 15 runners will be the only horses allowed in the covered holding area.
- Horses will not be worked on markers, barrels are not allowed in the arena during open ride or any other time September 27, 28, 29, 2013, except during UBRA time only.
- **Good sportsmanship** is expected at all times. We strive to run a fare and safe barrel race with an even playing field. Disqualification and forfeiture of entry fees may result for un-sportsman like behavior at any time during the event.
- Stall and RV Reservations are handled by Wasatch County: visit <u>www.utbra.com</u> Sept In Heber page. You will find a link to Wasatch County's stall reservation page. Wasatch County has plenty of stalls, when indoor stalls are sold out, outdoor stalls will be offered. Stalls will be reserved upon full payment. If you are going to be late make sure you have made arrangements with the county ahead of time 435-657-3335. No outside shavings allowed and please do not tie horses to trailers overnight.
- WPRA: Rider must be WPRA member to enter WPRA Side-pot. WPRA side-pots are per WPRA Rules.
- **Dr/Vet Outs** 70% of 5D entry fee will be refunded with Dr/Vet release. Must notify office before race starts. Refunds will be mailed out after the race. Disclaimer:

By signing and submitting this entry, I agree that I am aware of and will abide by the Rules and Regulations of the Utah Barrel Racing Association. In addition, I hereby waive any and all claims which may arise between myself and the Utah Barrel Racing Association or between myself and third parties (i.e. Davis County, Salt Lake County, Weber County, Tooele County, Utah County, Herriman City, Wasatch County, West Jordan City, the Board of Directors and the agents, members, servants and employees) as a direct or indirect result of my participation in any UBRA event. Should anyone or any legal entity bring such a claim, I agree to indemnify the UBRA. My waiver does not include any claim I may have against the UBRA for monies won as a result of my competitive performance at a UBRA event.

By signing and submitting this entry, I agree that I have been informed of the Utah Equine Activities Law (U.C.A. 78B-4-201 et seq.) and that there are certain risks inherent to my participation in an equine or livestock activity. I acknowledged that those inherent risks include dangers or conditions which are an integral part of equine or livestock activities, and may include the following: (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals; (c) collisions with other animals or objects; or (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability. Furthermore, I acknowledge that I am a Participant in an equine or livestock activity as defined by Utah Code Ann.78B-4-201 and that my status as a participant will continue through the duration of the entire event (i.e. even subsequent to my competitive turn).
