- \$50, Due by December 31st of weaning year, **AND**

Payment Schedule for Foals • TO SUSTAIN:

- \$50, Due by December 31st of yearling year
- \$50, Due by December 31st of 2-year-old year
- \$50, Due by December 31st of 3-year-old year

After December 31, 2010: Payment Schedule for the progeny of Pro Elite Sires that were not nominated during their weaning year is as follows,

- \$250, Yearling, Due by December 31st of yearling year to pay in full
- \$500, 2-year-old, Due by December 31st of 2-year-old year to pay in full
- \$750, 3-year-old, Due by December 31st of 3-year-old year to pay in full
- \$1500, 4-year-old, Due by December 31st of 4-year-old year to pay in full
- \$1750, 5-year-old, Due by December 31st of 5-year-old year to pay in full
- \$2000, 6-year-old & over, Due by December 31st of the year nominated to pay in full
- \$50 Late Fee (Must be paid before or with next scheduled payment.)
