### TERMS AND CONDITIONS

WPRA divisional circuit co-approval fees are non-refundable and non-transferrable. If event is not approved the approval fee will be refunded to the producer.

You must complete a WPRA form and submit it to the WPRA Office in order to produce a WPRA Divisional Circuit Co-Approval event. Non-member entries can be accepted at WPRA Divisional Circuit Co-Approval events.

All dates for WPRA Divisional Circuit Co-Approval events must be approved by the Circuit Director. A WPRA Divisional Circuit Co-Approval form and payment **must be received in the WPRA Office at least sixteen (16) days prior to the event.**

All changes to the event must be submitted to the WPRA Office at least 14 days prior to the event.

**Producer is responsible for submitting results and payoff to the WPRA office within three business days of completion of the event. If results are not received on time you may be forfeiting your future approval status.**

If a producer is putting on a WPRA sidepot (for WPRA Members only) the minimum added money is \$100 with a minimum entry fee of \$25.00. 5% of the total purse is payable to the WPRA.

**FUTURITY/DERBY:** For information regarding Futurity/Derby events, contact the WPRA Office or your Circuit Director. Details are provided in the WPRA Rule Book. We only approve futurity/derby events together with a minimum of \$100 added to each.

Please make sure confirmation is received when submitting an application. Feel free to contact the WPRA Office to ensure the application is received in a timely manner.
