## \*Open 2D Race Rules

- A horse/rider combination may enter the race once.
- The race will be held on May 10, 2014 at 12:00 Noon.
- The race will be run on a 2D format with a 1/2 second split.
- Entry fees for the main race will be paid back at 80%
- Added money will be paid back at 100%
- There will be \$250 added money to the Open 2D race.
- Entries will be accepted online and via mail from April 5, 2014 through May 5, 2014.
- All entries will incur a \$15 office charge
- A separate \$15 Late fee applies to all entries on the day of the race.
- Entry office will open at 9AM on the day of the race and remain open until 11AM.
- No refunds will be given for any reason.
- A paid competitor MAY NOT sell their slot. Draw-out and scratched slots will not be filled or resold.
- Horse OR Rider substitutions can be made on race day, and will incur a \$15 change fee. You MAY NOT substitute a horse and rider at the same time.
- Exhibitions will be run from 9AM to 11AM and can be purchased at the arena gate for \$5 per run. No exhibitions will be pre-sold.

## \*Open 2D Race Rules, Cont's

- Long sleeve shirts with collar and have either buttons or snaps on the front of the shirt, jeans without holes, western boots and western hat must be worn during a run.
- The draw will be a randomized computer generated draw. The preliminary draw will be posted on 05/06/2014, after the close of pre-entries. All entries received after that time will run after the preliminary draw in a second randomized computer generated draw.

## WPRA Junior Division Approved Youth Incentive Race Rules

- The Youth incentive is available to competitors 17 yrs or younger on January 1, 2014.
- Entry fee for the Youth incentive is \$50 & will be paid back at 100%
- Times from the Open 2D race will be rolled into the Youth Incentive.

## \*1D Incentive Rules

- The 1D incentive is available in each main race.
- Entry fee for the 1D incentive is \$50 & will be paid back at 100%
- Times from the Open 2D race will be rolled into the 1D Incentive.
