Rules:

Dress Code: Western Hat, Long Sleeve Collared Shirt, Pants, Western Boots

Entry Fee: \$250 per slot non-refundable. First payment option of \$125 is due postmarked 8/15/13 to reserve Slot. Final & full payment of \$125 must be received by 9/21/13 to be in the draw.

Individual or business may buy no more than 4 slots. Slots will be sold with no late fee until 30 slots are sold. Slots will be posted at www.utbra.com as sold. Rider for purchased Slots must be named by email to utbra.ut@gmail.com by Sunday Sept 22, 2013. Horse must be named day of race by 5:00 pm.

A random draw will be done and posted Monday, September 23rd. Horse & rider must run in order drawn or be disqualified. Slots sold/paid for after 9/21 will run at the end of the draw. Office must be notified of Buy-Outs by 5:00 pm day of race.

Slot owner can sell Slot (buy-out allowed).

Payout: If all 30 slots are sold, the payout will be \$7500: 1st \$3000, 2nd \$2250, 3rd \$1500, 4th \$750.

Rider may run 2 times (two slots, two different horses). Slot race is open to men and women, no age limit. WPRA Co-Sanctioned.

Rake every 5. A missed time will be given the option of a re-run or refund of entry fee.

If slot race is cancelled, 100% of entry fee will be refunded to original purchaser.

By signing and submitting this entry, I agree that I am aware of and will abide by the Rules and Regulations of the Utah Barrel Racing Association. In addition, I hereby waive any and all claims which may arise between myself and the Utah Barrel Racing Association or between myself and third parties (i.e. Wasatch County, the Board of Directors and the agents, members, servants and employees) as a direct or indirect result of my participation in any UBRA event. Should anyone or any legal entity bring such a claim, I agree to indemnify the UBRA. My waiver does not include any claim I may have against the UBRA for monies won as a result of my competitive performance at a UBRA event.

By signing and submitting this entry, I agree that I have been informed of the Utah Equine Activities Law (U.C.A. 78B-4-201 et seq.) and that there are certain risks inherent to my participation in an equine or livestock activity. I acknowledged that those inherent risks include dangers or conditions which are an integral part of equine or livestock activities, and may include the following: (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals; (c) collisions with other animals or objects; or (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.
