Due to the change in Formats resulting in an increase in the number of Contestants and very limited available space, both the Washington State Fair "Puyallup" and Ak-Sar-Ben's River City Rodeo & Stock Show (ARCR) "Omaha" will not be providing stalls. This was agreed to by the PRCA in order to increase the overall number of Contestants competing in both the Playoffs and Championships.

ARCR Omaha has worked with Horsemen's Park, the local horse racing track to offer stalls to rent for Contestants to house their horses. Below is information on the stalls and how to reserve them:

- **Reservations and Payment (Check or Credit Card) must be made in advance by completing the Reservation Form.**
- 90 stalls are available for Rent.
 - Fee is \$25 per Stall per Night.
 - Bedding not provided.
 - Straw is preferred, shavings are allowed.
 - Straw & Shavings are available in limited quantities on a first come, first serve basis.
 - Stalls are setup for Race Horses and don't have Gates or Doors on them, please bring a chain, panel or small gate to use.
 - Must be out of stalls by 9:00 a.m. the morning after the previous night's performance unless you rented the day after as well.
 - Stalls available starting at 1:00 p.m. the day of rental.
 - Any additional stalls requested after placing the first reservation doesn't automatically guarantee stall space. It is dependent on available stalls.
 - Likewise, if you want to extend your stall reservation(s), it is dependent upon available stall space.
- Free On-Site Parking for all Contestants who rent Stalls. (No electrical hookups)
 - **No tie outs or pens are allowed.**
- Free Exercise Area for Contestants to exercise Horse who rent stalls.
- Restaurant and Lounge inside Horsemen's Park for meals.
- The CenturyLink Center is 10-15 Minutes away depending on Traffic.

 - I-80 East Bound to Exit 449 (72nd Street Exit)
 - Right (South) on 72nd Street to "Q" Street
 - Left (East) on "Q" Street. Horsemen's Park on your Right.
- If Coming from the East:
 - I-80 East Bound to Exit 450 (60th Street Exit)
 - Left (South) on 60th Street to "Q" Street
 - Right (West) on "Q" Street. Horsemen's Park on your Left.

I agree to indemnify, defend and hold harmless the Releasees from any litigation expense, attorney fees, or claim for property damage or personal injury in connection with my activities on the Premises or with the Event. I further covenant not to commence or prosecute any action, suit, or other proceeding against Releasees as a result of any property damage, personal injury, wrongful death, or any other claim arising from my participation on the Premises or with the Event. This document shall be binding upon me, my estate, my legal representatives, my personal representatives, heirs, successors, assigns and guardians. This document shall be broadly construed and governed in accordance with the laws of the state of Nebraska.
