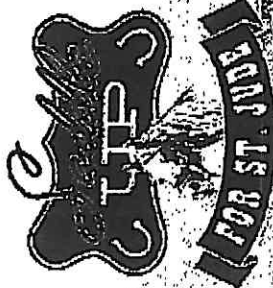

Coming to the Sonoma County Fairgrounds, the Sebastopol Wranglers are hosting their Charity Barrel Race (Fundraising for the Lung Cancer Memorial Race) on Sept 15th at 1:00pm. All are invited to watch the action and save the day!

The first level in the crown is BLUE. On Sept 16th is the "Are you TETRA?" Barrel Race for the Cure Race. This is our 3rd annual Barrel Race fundraiser with proceeds this year going to the Palisano/Benson Lung Cancer Memorial Race. Fundraising for the Lung Cancer Memorial Race is a fund providing free mammograms to those in need in Sonoma County, and throughout the North Bay.

The second level in the crown is OPAL. On Nov 4th is the Palisano-Benson Lung Cancer Memorial Race. This is our first year racing in memory of those that passed from Lung Cancer, Debra Palisano, 64 who, after only a short battle of 10 months, lost her battle to Lung Cancer. Debra was a 10 year non-smoker... this memorial is also dedicated to Taml Benson, 51 who after only 4 days of her diagnoses lost her battle to Lung Cancer. Taml was a non-smoker. This Barrel Race is to raise funds for Lung Cancer Awareness and early detection. All the proceeds will be donated to the Borin J. Adair Lung Cancer Foundation (BLCF) which is located in San Francisco and serves the entire Bay Area. BLCF is one of the largest philanthropies (patient-founded, patient-focused, and patient-driven) devoted exclusively to accelerating Lung Cancer through research, early detection, education, and treatment. The Foundation works with diverse group of physicians, organizations, industry, partners, individuals, survivors, and their families to identify solutions and make timely and meaningful change.

The third & final level in the crown is EMERALD. On Dec 2nd is our 3rd annual Saddle Up for St. Jude Barrel Race with proceeds benefiting St. Jude Children's Hospital.

The Triple Crown Champion will be presented with a trophy and a check at the close of the Saddle Up for St. Jude Race. All are invited to watch the action and save the day!
