Special Notes

- Dogs must be on a leash at all times and under the control of an adult.
- No tying to fences, buildings or panels at any time
- Dress Code: Long Sleeve Shirts & Cowboy hat or Helmet
- A horse can be entered in a race only once; no sharing.
- **No scratches after the rider is placed in the draw;** substitutions are allowed for \$10 fee, draw position will be lost.
- **Vet Out Policy:** Vet outs must be submitted **prior** to the race start with documentation that the horse has been examined by a Vet and is unfit for competition. Horse will be ineligible for competition for 10 days following the vet out. Vet outs will receive 70% of entry fees only
- NCHI will determine eligibility for a rerun and also determine where in the draw any granted rerun will occur.
- Timed runs are \$5 each; pay at the gate
- Pee Wee race will be held before the Open race. All contestants will win a
