Wasatch County/UBRA Summer 5D Clarifications

This form must be signed and accompany entry form



- ☺ Open 5D will be 1/2 second splits. Average prizes awarded based on fast time from each day.
- ☺ All runners will enter the arena thru the holding pen and exit out the alley way. No exceptions. Any runner entering from anywhere other than the holding pen will be disqualified.
- ☺ 5D Pre-entries must be postmarked by 7/13/11 or will be charged a \$10 late fee. Late entries will be taken the day of race until the last 50 runners and will also be charged the \$10 late fee. Late entries taken on Saturday for both days will run at the end on Saturday and Sunday.
- ☺ Pre-entered day runners will be included in the draw. There will be separate draws done for the Open 5D Saturday and Sunday, late entries will run at the end both Saturday and Sunday.
- ☺ Saturday running order will be: Open 5D Pre-entries then late entries. Sunday running order will be: Open 5D (new draw) Pre-entries then late entries followed by 5D Award Presentation. Must be present or have a designated person pick up your award at the race.
- ☺ For Stall and RV Reservations: Go to the Wasatch County Event Center website at www.co.wasatch.ut.us/eventcenter Stalls will be reserved upon full payment. If you are going to be late make sure you have made arrangements with the county ahead of time. No outside shavings are allowed. Each stall will include 1 bag of shavings. Additional shaving can be purchased online or at the event center for \$10. RV Hookups are not located on the fairgrounds and are approximately 1/2 mile from the arena.
- ☺ The 4D race on 7/22 and Open 5D races held on 7/23 and 7/24 are WPRA co-sanctioned.
- ☺ Target cash will be awarded thru 3rd place: 1st Place \$600, 2nd Place \$300 and 3rd Place \$100.
- ☺ Dogs are restricted from entering indoor facility. Please keep your dogs outside and at your trailers.
