Stallion enrollment is annual. The annual season shall be January 1, 2025 through December 31, 2025.

- All Enrollments (September 1 of the previous year — April 15) will have a fee of \$1,000.
- Late Enrollment (April 16 — October 31) will have a fee of \$1,500.
- Very Late Enrollment (November 1 — November 30) will have a fee of \$2,000

**Enrollment along with payment must be received in the WPR office by the dates listed above.**
