## RODEO INFORMATION WPRA BREAKAWAY ROPING: Number of Contestants Per Perf Per WPRA Rule 10.1.15. Breakaway will be set up for at least 10 in each performance unless otherwise approved and stated in the ground rules. • Healthy calves, preferably a minimum of ½ the number of entries will be required. • The calves should range from 200-400#. These calves are to be even with no more than 50# variation across the herd. Added Money (added by the committee): \$ (\$00.00) # Perfs # Go's # Slacks WPRA Breakaway Equal Added Money Plan 2024 – Must have added at least 50% of the barrel racing added money (unless a new rodeo or used an exemption listed below) 2025 – Must add at least 75% of the barrel racing added money 2026 - Must add equal money to the barrel racing 2027 – All rodeos (including exemptions) must add equal money **Exemptions** \* New rodeos adding breakaway roping for the 1st time must meet the minimum added money requirement of \$500. Then their 2nd year having breakaway, they must add at least 50% of the barrel racing and so on to follow the 3-year step up plan to equal money. Each year thereafter the minimum requirement will be increased, and all rodeos must be at equal added money in the breakaway by 2027. \* If the rodeo is currently limited, and the rodeo removes its limits, they will be given a year of grace to meet the next added money requirement. i.e., In 2025 the rodeo removes its limit on breakaway, so it will not have to be at 75% added money until 2026. This is a onetime exemption, and all rodeos must be at equal added money in the breakaway by 2027. \* Rodeos that add \$5,000 or more in added money will also be given a year of grace to meet the next added money requirement. i.e., In 2025 the rodeo adds \$5,000, but needs to be at \$7,500 to be 75% of the barrel race, so it opts to exercise this exemption in 2025 and will not have to meet the 75% requirement until 2026. This is a onetime exemption, and all rodeos must be at equal added money in the breakaway by 2027. The type of Insurance must be Commercial General Liability-Occurrence Form. No "claims made form" coverage will be accepted. Limits of Liability will be \$1,000,000 each occurrence and \$2,000,000 General Aggregate. The coverage must include: Bodily Injury and Property Damage, Products Liability, Personal Injury Liability and Contractual Liability. Additional insureds must be shown on certificate: Women's Professional Rodeo Association, their officers, directors and employees.
